

Syngenta's Data Privacy Pledge to Growers

We live in a world where personal information is hacked, breached, bought, and sold. But Syngenta takes your data privacy very seriously. That's why we've taken the steps to protect growers' data within our Cropwise® digital products. Syngenta customers can rest assured knowing their Cropwise® data are secured and not used, sold, or shared without their knowledge and authorization.

Syngenta maintains the following principles of privacy for Cropwise® data:

- Grower data are the property of the grower;
- Grower data are used to support the grower;
- Grower data are only shared at the request or as authorized by the grower;
- Grower data are not analyzed, aggregated or mined except as requested or authorized by the grower.

With the Cropwise® platform, growers can expect the following:

- Growers continue to own and control their data;
- Growers who use multiple Cropwise® digital products will have one login to access and enter data;
- Growers have the option to opt-out of any digital product or service offerings;

Transfers to Third Parties:

- We will disclose personal information to third parties only for purposes consistent
 with those for which the personal information was originally collected or to which
 the data subject has subsequently consented.
- We will take appropriate measures, by contract or otherwise, to provide protection for personal information we disclose to our affiliates, service providers and other third parties.
- We will obtain the data subject's consent in accordance with applicable law before disclosing personal information to a third party. The type of consent required will depend on the context and the circumstances, the sensitivity of the personal information, the data subject's reasonable expectations and legal requirements.
- There may be exceptions to these general principles, depending on the applicable law, if, for example, the disclosure is required by court order, to comply with a law, to prevent a crime or enforce a legal right.

More generally, Syngenta abides by the US Farm Bureau's Privacy and Security Principles when handling Grower data. Per our Digital Ag Solutions Commercial Policy:

- **Notice and Consent** Syngenta will process personal information fairly and lawfully. We will only use customer data with the full knowledge or consent of the customer.
- **Specific Purpose** Syngenta will process personal information only for specific, documented, limited and legitimate business purposes.
- **Limitations on Use** Syngenta will process personal information only in a manner consistent with the purposes for which it was originally collected, except as required by applicable law.
- **Data Proportionality** All data collected will be relevant, adequate, and not excessive for the purposes for which it is collected or to which the customer subsequently consents.
- **Direct Marketing** Syngenta will not use personal information for direct marketing purposes without the customer's consent. The customer's consent may be express or implied, "opt-out" or "opt-in", depending on the circumstances and applicable law.
- **Automated Decisions** Syngenta will not make decisions based solely on automated processing of personal information except as permitted by applicable law.
- **Privacy Awareness** Customers will be given notice of Syngenta's information practices before any personal information is collected.
- Choice Customers will be given a choice about how information about them is used.
- Access Customers have the right to access information Syngenta has obtained from them and request correction to ensure the information is accurate and complete.
- **Security** Syngenta will take commercially reasonable security safeguards to ensure that information is protected against risks such as loss or unauthorized access, destruction, use, modification, or disclosure of data.
- **Retention** Syngenta will not keep personal information for longer than is necessary for the purposes for which it was collected or to which the customer has consented, except for legitimate purposes permitted by law, such as regulatory compliance.
